# Sanofi releases Innovate Reconciliation Action Plan outlining next steps to support a more equitable Australia

**Australia, 7 August 2023**. Sanofi has released its Innovate Reconciliation Action Plan (RAP), formally endorsed by Reconciliation Australia. As the organisation's second RAP, the plan outlines Sanofi's next steps in support of equality, equity and voice for Aboriginal and Torres Strait Islander peoples.

This RAP builds upon Sanofi's long-standing commitment to hearing the voices, and seeking to improve the lives, of the people and communities it serves. This has meant intentional and deep listening to Aboriginal and Torres Strait Islander leaders and their calls for greater self determined action.

Over recent years Sanofi has:

- Supported the launch of, and then expanded support for, NACCHO's Aboriginal and Torres Strait Islander Pharmacist Scholarship program, which has already seen 11 scholarships awarded over two years.
- Collaboration with the Australian Diabetes Educators Association and UTS to deliver an Indigenous scholarship for the UTS Diabetes Education and Management Certificate.
- Provided public support for, and advocacy to advance understanding of, the Uluru Statement from the Heart including a constitutionally enshrined Voice to Parliament.

The Innovate RAP reinforces Sanofi's existing commitments and extends its focus to improve First Nations economic participation. This includes action to improve representation of Indigenous owned businesses within the organisation's supply chain and new strategies to improve recruitment and retention within Sanofi's employee group.

Joining with corporate Australia to improve economic participation: One of Sanofi's first actions under its Innovate RAP has been to join the Business Council of Australia's Raising the Bar initiative. As a member, Sanofi has committed to working collaboratively with other Australian business leaders to increase procurement spending with Indigenous owned suppliers.

Artist, Jeremy Donovan a Kuku-Yalanji and Gumbaynngirr Man from the First Nations of Far North Queensland and the Mid North Coast of New South Wales, was commissioned to create the artwork featured throughout Sanofi's Innovate RAP. In celebrating the artwork, Jeremy said it was inspired by the values and colour of Sanofi.
